FAMILY GOLF EQUITY MEMBERSHIP

- Initiation Fee: \$1500 (½ Waived during the program period)
- **\$750 due and payable on the following schedule:**
 - \$ 375 payable with application
 - \$ 375 due 12 months after application approval
- Monthly Dues and Capital Assessment \$275
- Monthly Food Minimum \$30

- ❖ Membership includes unlimited golf and all clubhouse amenities.
- ❖ Monthly dues and Capital Assessment will be **waived** until April 1, 2012
- ❖ The new Family Golf Equity Member will receive a **\$55 credit** on their monthly statement for **Twenty Four Months beginning April 1, 2012**
- ❖ Each new Family Golf Equity Member will receive 4 guest passes. These guest passes are for new potential members that have not experienced the Logan Country Club Family. The same Guest cannot be invited more than once.
- ❖ The new Family Golf Equity Member will be eligible to receive their credits after they have attended an orientation meeting with the Club Secretary.

JUNIOR ASSOCIATE MEMBERSHIP

An Individual must be between the ages of 21-34 to take advantage of this one time offer.

- Initiation fee: \$500
- \$500 due and payable upon the following schedule:
 - \$250 payable with application
 - \$250 balance due 12 months after application approval or before age **THIRTY FIVE** which will satisfy his/her full golf non equity membership

- Monthly Dues \$140.

- Monthly Food Minimum \$30
 - ❖ Membership includes unlimited golf and all clubhouse amenities.
 - ❖ Monthly dues waived until April 1, 2012.
 - ❖ The Junior Associate Member will receive a **\$28 credit on their monthly statement for 24 months or until they have reached their 35th birthday, beginning April 1, 2012.**
 - ❖ Each new Junior Associate Member will receive 4 guest passes. These guest passes are for new potential members that have not experienced the Logan Country Club Family. The same Guest cannot be invited more than once.
 - ❖ The new Junior Associate Member will be eligible to receive their credits after they have attended an orientation meeting with the Club Secretary.

CORPORATE GOLF MEMBERSHIP

- Initiation fee: \$3,000 (for up to six corporate employees, clients or for use as an incentive program within sales organizations)
- \$3,000 due and payable upon the following schedule:
 - \$1,500 with application
 - \$1,500 due 12 months after acceptance
- If the new Corporate Member pays his/her initiation fee up front (\$3,000), a 10% discount will be deducted from the initiation fee. **Plus a \$1,000 credit** will be applied to the corporation's account for a future company celebration of their choice (this \$1,000 credit must be used within 18 months of membership acceptance).
- Monthly Dues and Capital Assessment \$275 (for each individual assigned a Membership)
- Monthly Food Minimum \$30 (for each individual assigned a membership)
 - ❖ The corporation owns each membership and can assign them in anyway beneficial to the corporation or it's employees
 - ❖ Each corporate member is a full family membership inclusive of all amenities
 - ❖ The corporation will receive **\$55 credit per month for Twenty Four Months** off of each designee's membership dues once the corporation places three members with the club. The **\$55 credit** will end prior to

twenty four months if the corporation's number of designees drop below three members.

- ❖ The new corporate member will be eligible to receive their credits after they have attended an orientation meeting with the Club Secretary.

- **Business Qualifications:**

- This membership is for corporations or small businesses that fall under the guidelines set by the Logan Country Club Board of Directors and the current by-laws of Logan Country Club.
- A corporation eligible for such membership must be deemed a single, legal entity, e.g. ABC Corporation, not ABC Corporation and its sub-contracting vendors.
- This program is applicable to non-existing members that have not held membership at Logan Country Club for the past 4 years.
- Corporations or Small Businesses must have minimum of 15 employees.

CLUBHOUSE SOCIAL MEMBERSHIP

- Initiation fee: \$00.
- YEARLY Dues \$100.
- Monthly Food Minimum \$30
- ❖ The Social Member, social member spouse and dependent children can participate in the dining and social activities at Logan Country Club.
- ❖ The Social Member and social member spouse can bring guests for dining and social activities.
